



## **St John Fisher Catholic Primary School**

### **Nursery Admissions Policy: 2022/23**

St John Fisher Catholic Primary School is a fully inclusive school located in the parishes of Sacred Heart and Blessed Dominic Barberi, Oxford. The school caters for 252 children, 3-11 years old, and provides children with an education inspired and guided by the teachings of Jesus Christ. We aim to continually strengthen the vital partnership between home and school and in doing so recognise and value parents as the first educators of their children.

***This policy should be read in conjunction with Oxfordshire County Council's Policy for Nursery Admissions***

1. St John Fisher Primary School Nursery offers places to children who are 3 years old, commencing in the term following their third birthday
2. Admission to our nursery takes place thrice yearly in September, January and April. Terms dates are determined by Oxfordshire County Council
3. Our nursery operates during school term-time only - 38 weeks per year
4. Our nursery has an agreed published admission number (PAN) of 52 part-time equivalent (PTE) places
5. Parents will be notified that a place is available for their child no later than four weeks in advance of the new term
6. Late applications will be accepted up until the end of the second week of the term in which a place has been requested. After this time funding allocations are made and late applicants will be invited to start during the following term

7. When completing an application form, parents will be asked to indicate whether they would prefer a morning, afternoon or full-time place; however, the allocation of a preferred place will ultimately be dependent on the number of places available in relation to the PAN
8. Should you not be offered your preferred place, your name will be added to a waiting list and you will be informed immediately should your preferred place become available; however, changes can only be made from the start of each term
9. Prior to the allocated start date, parents will be invited to pre-start induction meeting so that they may meet the nursery team and complete all relevant paperwork
10. All children are entitled to free 15 hours (Universal) nursery entitlement
11. We offer both Universal (15 hour) and Extended (30 hour)\* entitlement within our provision and will offer places which equate to, but do not exceed, the total full-time equivalent (FTE) places of our PAN

*\*Information on how to apply for extended 30 entitlement is available from the school office and on the school website*

12. One PTE place amounts to 15 hours per week which equates to 570 hours a year (38 weeks\*15 hours)
13. One FTE place represents two PTE places which equates to 1140 hours a year (38 weeks\*30 hours)
14. St John Fisher Primary School Nursery does not permit parents to split either their universal 15 hour entitlement or extended 30 hour entitlement with another provider
15. Once an offer of a place (either part-time or full-time) has been accepted, children are expected to attend for the agreed number of hours
16. Daily nursery sessions run as follows:

**Part-time children (universal 15 hour entitlement)**

- o Morning only nursery: 3 hours per day, 5 days a week: 8:30am to 11:30am\*
- o Afternoon only nursery: 3 hours per day, 5 days per week: 12:00pm to 3:00pm\*\*

*\*Morning only nursery: children do not stay for lunch*

*\*\*Afternoon only nursery: children should eat lunch prior to attending the setting*

**Full-time children (extended 30 hour entitlement)**

- o 6 hours per day, 5 days per week: 8:30am to 3:00pm

17. Full-time provision includes a 30 minute break for lunch (11:30am-12:00pm). Lunch breaks are not funded; however, St John Fisher School Nursery will look after your child at no additional cost

18. A cooked school meal is available from the canteen at a cost of £2.40 per day\*; alternately, you may provide your child with a packed lunch\*\*

*\*Children in receipt of Early Years Pupil Premium (EYPP) are entitled to a free school meal*

*\*\*Please ensure that packed lunch does not contain nuts or any food that may contain nuts - please check the ingredients if you are unsure*

19. So that we may gradually integrate new children into the setting, it is our policy to insist upon staggered start dates, each term, for new starters. This practise promotes a calm environment in which the children can meet the staff and become accustomed to their new surroundings

20. Staggered starts will take place during the first two weeks of the new term and will be dependent on the number of new children attending

21. During this period we may also recommend a reduced timetable to aid the transition from home to nursery. Reduced timetables will be implemented for a period of time as mutually determined at the pre-start meeting and will be appropriate to the child's individual needs. This is particularly important for children taking up the offer of a full-time place. The number of hours initially agreed will be reviewed regularly and adjusted in accordance with the child's progress

22. Staggered starts will not apply to children who have attended St John Fisher Nursery in a previous term

23. Should a family not be eligible for funded, extended 30 hour entitlement, St John Fisher Nursery will allow parents to pay for the additional 15 hours to enable their child to attend full-time nursery (please see 15)

24. Extended entitlement fees are calculated as follows:

- Number of extended hours per day: **3**
- Charge per Hour: **£4.35**
- Daily Charge: **£13.05**
- Weekly Charge (5 days): **£65.25**

25. Invoices will be issued on a weekly basis and must be paid within seven days of the issue date (unless otherwise arranged)

26. Payment is to be made by way of bank transfer via the School Gateway app. Details of how to install the app and access payment requests is included with this policy.

27. Where a family ceases to be eligible for the extended entitlement, the place will return to the universal entitlement level upon expiration of the grace period; this is unless the parent agrees to pay for the extended hours
28. Parents will be allowed to keep the child in their universal entitlement place even if they cease to be eligible for the extended entitlement
29. When allocating places, children entitled to funded extended entitlement will be given priority over those from fee-paying families
30. There is no requirement for St John Fisher Nursery children to wear a school uniform; however, red school jumpers with the school logo are available from the office reception
31. In accordance with Oxfordshire County Council's Nursery Admissions policy, when more applications are received than there are places available, the requisite County Council criteria must be applied. These conditions closely follow the admissions criteria for entry to County primary schools
